

CLINTON COMMUNITY COLLEGE'S FACULTY ASSOCIATION ANNOUNCE A UNANIMOUS "VOTE OF NO CONFIDENCE" IN JOHN KOWAL, PRESIDENT.

On Thursday, April 13,2023 all present teaching and non-teaching members of the Faculty Association (FA) **unanimously** voted No Confidence in the President of Clinton Community College (CCC), John Kowal. The FA membership finds that John Kowal **lacks or is unable to demonstrate** the needed leadership qualities or skills that are critical to ensure the betterment and future of the College. He has failed in his tenure as President of the College to meet his stated goals while serving as administrator-in charge and seeking the position of President in 2021.

As President of Clinton Community College, John Kowal is unable to unite the people he leads to convey a shared mission and to create and maintain a positive work environment. This inability to inspire, motivate, and model collaboration has led to a large number of resignations in key positions within the President's Cabinet, the faculty, and in other important areas across the campus in recent months. Some of these individuals have chosen to leave the College without a new, secured position rather than to remain working under his lack of leadership.

The FA vote of No Confidence reflects that John Kowal has been aware of the dire Campus Climate under his watch for two years and that having many resignations, an unprecedented number in the history of the college, is not unexpected because he is unable to demonstrate skills to make positive progress. A Campus Climate Survey in 2022 at CCC reported employees across campus, not limited to the FA, are experiencing negative and unhealthy work situations. The survey results indicated respondents were skeptical that concerns would be taken seriously and documented that employees feared punitive consequences or retaliation for expressing concern. This fear of punitive retaliation by the leadership of the college under John Kowal's watch, in addition to an increased level of concern of retaliation towards Union leadership, specifically impacting the role of FA

President, led in March 2023 to the FA filing a muti-tiered "Improper Practice Charge" against the College with the State of New York's Public Employment Relations Board (PERB). Multiple violations with supporting evidence have been evaluated and screened by the PERB process and have been deemed to have merit and approved to move forward in the PERB process. A PERB conference has been scheduled for May 1, 2023.

The FA lost confidence in John Kowal's management and decision-making skills when in January 2023, he approved that a mandatory opening day, public session take place to discuss the Climate Survey concerns being felt by individual employees. John Kowal ignored employees' claims of discomfort with the format and allowed the session to continue until a staff member was able to get his attention to end the unproductive and ill-thought-out way to address concerns in the survey. This failed attempt to address the high level of climate concern led to John Kowal stating, "It was the worse day of my life," yet it did not motivate him to seek productive ways to move forward in improving the climate.

While not an official member of the college negotiation team, John Kowal does not publicly state support for his faculty. He does not create or promote urgency to resolve the contract. He chooses not to use his voice and position to celebrate and to draw attention to the excellent student evaluations of his teaching and non-teaching faculty, or to highlight and celebrate the numerous accolades of teaching and non-teaching faculty cited in the 2022 MSCHE Middle States Report of the faculty at Clinton Community College.

Arbitrary decisions are being made and approved by John Kowal that are not data- or evidence-based. Rationale for decisions is not student-focused, not fiscally responsible, and seemingly supports a personal agenda and not that of a leader of an organization. The FA asserts that President Kowal has created an atmosphere of "favored status" and that he knowingly pursues actions that ignore and disregard binding conditions of the existing contract with the FA. For example, a recent violation being evaluated by PERB took place when an individual position within FA was awarded a 10% base pay increase. This hand-picking of positions to reward does not follow the precedent and contractual mandate to work with FA on changes to pay or work responsibilities of FA positions.

All of the above culminated in a tipping point for the unanimous vote by members of the FA at the meeting on April 13 to vote No Confidence in the leadership of President John Kowal. Members were unable to accept the lack of student-focused decision-making, his inability to facilitate, compromise, or demonstrate the desire to seek positive solutions, as well as his inability to prioritize and allocate resources in the interests of students and academic programs outside of contract.

Members of the Faculty Association will be present at the next Board of Trustees meeting that is scheduled for Tuesday, April 18th at 5:00pm, and if given an opportunity to speak to the BOT, will speak to this vote of no confidence.
