Need a 2021 IRS Return Transcript?

1. Go to www.irs.gov , click on “Get Tax Transcript” or call 1-800-908-9946.

OR

Use Data Transfer Tool on FAFSA

Avoid the hassle of getting an IRS tax return transcript or giving us copies of taxes, by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA. This option is available for most students & parents.

- Go to <https://studentaid.gov/h/apply-for-aid/fafsa>
- Navigate to Financial Information Section
- If you're eligible to use the tool, look for a “link to IRS “ button
- Be sure to transfer the data from IRS website BACK to FAFSA
- Once back on the FAFSA webpage, click “submit” corrections
- CCC will receive a corrected FAFSA

Check the CCC Student Portal often for status of your documents.
